Abstract

This article talks about the work being done in the fight against corruption in Kashkadarya region and their stages, as well as principles.

Kashkadarya region is one of the largest temporary quality regions of the Republic of Uzbekistan. In addition, there are many factories, machinery factories, construction material producing organizations that have been developed and built. Also, when special attention is paid to the economic development of the region, MKB is a member of the agrofusion organization "Limak Marash". This organization has made calculations focused on the largest variety of home improvement and service issues in Uzbekistan. However, it is known that Kashkadarya region, like all other regions of Uzbekistan, faces the problems of corruption and official injustice. Such situations have a severe impact on economic development and the activities of organizations. The government of Kashkadarya region has issued several decisions to eliminate these problems. Addressing injustice and corruption by regional leaders through official actions is directly related to the creation of a legal order. The main task of this procedure is to organize a special exchange of information between employees and employees.

As mentioned, today the banking sector is one of the systems where most corruption crimes are committed in the republic. In Kashkadarya region alone, in 2021, 22 criminal cases against 29 persons who worked in the banking system were sent to court. In particular, they committed crimes such as embezzlement or embezzlement, fraud, abuse of power or authority, bribery. Of those who committed these crimes, 4 people are bank service employees at the regional, 25 district and city levels. What are the causes of such corrupt situations, how can existing problems be solved? The information of the regional prosecutor, banking system officials was heard on the topic. It was noted that the figures related to the corruption cases in the banking system clearly show the need to further improve the system of combating and preventing corruption in the region. For this, it was noted that each department and agency should critically review their activities.

Qashqadaryo viloyati boshqa hududlar bilan taqqoslaganda korrupsiya darajasi bo'yicha yuqori o'rindarda turgani qayd etildi. Jumladan, korrupsiyaga oid jinoyatlar sodir qilish ko'rsatkichi bo'yicha **viloyat o'tgan 3 oyda eng yuqori o'rinlarda turibdi. Xususan, fevral oyida 45 ta jinoyat ishi bilan 1-o'rinni, mart oyida esa 46 ta jinoyat ishi bilan 4-o'rinni band etgan.** Shu kabi salbiy tendensiyalarni bataraf etish, viloyatda korrupsiyaga qarshi kurashish ishlari samaradorligini oshirish maqsadida Agentlik tomonidan viloyat hokimligi hamda Korrupsiyaga qarshi kurashish hududiy kengashi hamkorligida Qarshi tumanida **"Korrupsiyasiz hudud" loyihasi** amalga oshiriladi. Loyihani amalga oshirish uchun **29 banddan iborat "Yo'l xaritasi" ishlab chiqilib, tasdiqlandi.**¹
