In today's development processes, the Republic of Uzbekistan "On Non-Governmental Non-Commercial Organizations", "On guarantees of the activities of non-governmental non-profit organizations", President of the Republic of Uzbekistan dated May 4, 2018 "Measures to fundamentally increase the role of civil institutions in the process of democratic renewal of the country" Historical Decree No. 5430 and other regulatory and legal documents adopted in the next two years are significant in that they aim to further develop the activities of non-governmental non-profit organizations, ensure their independence, and protect their rights and legal interests.
